The Fair Debt Collection Practices Act is a federal consumer protection law that establishes certain rights when dealing with collection agencies.

One way to stop harassing phone calls from a collection agency is to send them a Cease and Desist Letter, requesting that they stop contacting you.

When you tell the collection agency to stop calling you regarding what you owe, they cannot, by law, call you again.
