In most parts of the country, collecting and selling personal data is not illegal, as long as the company or website informs you that they are doing so.

If you send this letter within 30 days from the date that the debt collector first contacted you, the debt collector

must stop collection on the debt.

Cease & Desist Letter for Debt Collectors [Proven Template] If you want a debt collector to stop contacting you, Section 805 (c) of the Fair Debt Collection Practices Act (FDCPA) gives you the right to ask them to stop — and they must comply upon receipt of your letter.
