You have the right to STOP collection agencies from ever writing or calling you again.

By law, a collection agency must stop contacting you after they receive a letter telling them to.

These agencies help taxpayers settle their tax debts.

Copied! If you are consistently being harassed by collection agencies regarding alleged past due debt obligations, a cease and desist letter should stop the constant phone calls once and for all.

Can I Sue for Unwanted Phone Calls?

Harassment: Debt collectors may not use threats of violence, use obscene language, publish a list of debtors (but they can report to credit agencies), or repeatedly use the phone to annoy someone.

Scams The number they call from is different every time. The TCPA restricts the making of telemarketing calls and the use of automatic telephone dialing systems and artificial or prerecorded voice messages.

You've already begun a formal process to make or contest payments.
