If you want a debt collector to stop contacting you,  
Section 805 (c) of the Fair Debt Collection Practices Act  
(FDCPA) gives you the right to ask them to stop — and  
they must comply upon receipt of your letter.

Although the law requires debt collectors to treat you fairly and prohibits certain methods of debt collection, it does not erase any legitimate debt that you owe.

FAQ's From Consumers Arizona A: To ensure that the collection agency's calls stop, you must give the collection agency written notice stating that you refuse to pay the debt, or requesting that the collection agency stop all further communication (a cease and desist letter).
