Once the collector receives your letter, they may not contact you again except to say there will be no further contact or to notify you that the debt collector or the creditor intends to take some specific action.

The Fair Debt Collection Practices Act also allows you to tell creditors to stop calling altogether.

For example, you can tell creditors to call you at home only between 6 and 8 p.m.
