collector without ever billing the patient. There's no good
reason why this happens other than poor accounting

Of course, another way to stop collections harassment
(and the debt collection process as a whole) is to simply
pay off your debts.

The Problem. New technology has made unwanted
telemarketing calls hard to stop.

If the calls continue after a few business days, keep track
of the incoming calls.

If Possible, Pay Your Debts in Full.

get off your back and leave you alone.

Stop payment orders generally expire after six months. Give the collection agency three to five business days to process your request.

Wisconsin Consumer Act: Debt Collection Practices wdfi.org The federal Fair Debt Collections Practices Act (PDF: external link) provides that, for collection agencies, the consumer must contact you within 30 days of receiving the initial notice to inform you they are disputing the debt.

When you stop payment, the company you gave the check to will be unable to get any money for it—unless it cashed the check before you stopped payment.

They need to provide paperwork proving who they are and what they can repossess.
