The collection agency must then halt collection activity until a copy of the verification is sent to you.

Although the law requires debt collectors to treat you fairly and prohibits certain methods of debt collection, it does not erase any legitimate debt that you owe. If a debt collector contacts you about a legitimate debt, be cooperative but also expect to be treated professionally.

with me after being notified in writing that I no longer wish to communicate with you (Fair Debt Collection Practices Act [FDCPA] Section 805(c): CEASING COMMUNICATION).
