law that requires collection agencies to stop contacting
you if you send them a letter stating that you wish to
stop contact.

Just do it in writing, and contacts must stop, unless
they're to tell you that collection efforts have ended or
the agency is going to take a specific action (like filing a
lawsuit) against you.
