Protecting Your Credit If You Cannot Afford Rent COVID

If you don't pay your credit card bill, car loan, or mortgage, the creditor will report the delinquency to the three major credit reporting bureaus (Equifax, Experian, and TransUnion) and an adverse notation will appear on your credit reports.

Due to Public Law 104-113, Debt Collection Improvement Act, copayments for medical care and pharmacy services delinquent 90 days or more are subject to a reduction of VA benefits to satisfy the balance. Copayments delinquent 120 days or more are subject to referral to the U.S.

Within one (1) business day of marketing a property to
