Bare bones...there are only three ways to stop collection calls and letters: Run Away/Hide.

If you're interested to deal with your original creditor regarding payment of debt and would not like to interact with the collection agency, you'll need to stop their collection efforts.

Right-click the driver that you want to disable.

Before you pay the debt, send a validation letter requesting that the collector provide you with proof that the debt is yours and you're legally obligated to pay it. This is a five-step process for a worse case non-payment scenario.
