Child Support Liens Wisconsin A child support lien is a hold placed on property (such as land and cars) until past-due child support is paid.

A collection warrant is a lien that is enrolled on the judgment book at the Circuit Clerk's office to collect on an overpayment.

These liens will be placed without a court hearing.
