Stop a Wage Garnishment with an Installment Payment Plan In the case that a creditor files a judgment against you for a debt, an option to consider (if it is available in your state) is an installment payment plan.

You will typically send a total of four letters before hiring a collection agency or recording a bad debt expense. Some state laws provide exemptions to families as well as individuals with medical debt that will in effect protect more of their incomes from the collection process.
