Canada?

You may be owed \$500 to \$1,500 per call depending on if you told them to stop calling or that they were calling the wrong person.

The FTC defines "repeatedly" as "calling with excessive frequency under the circumstances."

Although the law requires debt collectors to treat you fairly and prohibits certain methods of debt collection, it does not erase any legitimate debt that you owe.
