Bankruptcy is a legal proceeding in which an individual who cannot pay his or her bills can get a fresh financial start.

Most federal student loan payments are suspended, and interest is waived, through Janu, due to the COVID-19 national emergency. Collection actions, wage garnishments, and Treasury offsets, like tax refund offsets and Social Security intercepts, for defaulted federal student loans are also paused during this time.

Once your refund status on the IRS shows "Refund Sent" it can take 1 to 5 business days for the financial institution to deposit fund into your account.

A Chapter 13 bankruptcy case generally remains open for a minimum of three years and a maximum of five years. The right to file for bankruptcy is provided by federal law, and all bankruptcy cases are handled in federal court.

Contacted by a Debt Collector?

Typically, a Chapter 7 bankruptcy will take between four and six months from the time the debtor files until the debt is discharged.

A Chapter 13 bankruptcy can provide for level monthly payment of your tax obligation without additional interest or penalties.
