The simplest strategy to stop collection harassment is to
write the collector a "stop contact" letter, also called a
"cease" letter.

Once you pay them, the debt collection agency should
get off your back and leave you alone.

This is where the Request Letter to stop contact can help.

Please understand that this is our final notice to you.

If the debt collector continues to contact you after
they've received your letter (beyond the one additional
time allowed by law), you can provide proof of the letter's
receipt to file a complaint or lawsuit against the debt
collector for further unlawful collection action.

Debt collectors using fake summons to entrap their
consumers will typically issue fake summonses with
limited legal language or terminology (if any at all).

Don't make an empty threat.

The letter should also contain the account number, amount of debt, and documentation that may help stop the harassment.
