When a Debt Collector Calls, How Should You Answer?

You still have to deal with your debt.

The CFPB has prepared sample letters to help you get information, set limits or stop any further communication, or exercise some of your rights.

Before you pay the debt, send a validation letter requesting that the collector provide you with proof that the debt is yours and you're legally obligated to pay it.

Owing a debt does not automatically subject you to harrasing, threatening and other inappropriate collection agency behavior.
