Debt Collection Laws: FDCPA, TCPA, HIPAA and FCRA Illinois Collection Agency Act The Illinois collection agency act (ICAA) requires that all debt collectors must have a license before being operational.

Debt collectors generate more fraud reports to the FTC than any other industry.

A creditor violates this section if he uses the name of a collection bureau as a conduit for a collection process that the creditor controls in collecting his own accounts.

How to Stop Ongoing Harassment From a Collection Agency The federal Fair Debt Collection Practices Act provides the consumer with a legal avenue to prevent collection agencies from continual harassment.

I am requesting that you cease and desist with your efforts to collect on the debt referenced above.

New York City: Debt collectors must be licensed as debt collectors by the NYC Department of Consumer Affairs and cannot call the debtor more than twice a week about a debt.

If this happens, the consumer can send a cease and desist (C&D) letter to the collection agency requesting or insisting that they stop harassing communication.

According to the FCRA, you have the right to view any information on your credit report for free once every 12 months.
