Debt collection letter template, informing the debtor that legal actions have begun and that from this point onwards, court representatives will contact the debtor. Such letters fall under different County Court Judgment.

Consumer Financial Protection Bureau 2015-9-29 · You're saying: "Stop contacting me." Use the sample letter on the next page if you want to tell the debt collector to stop contacting you.

Interactive Form Collection Agency Stop Contact Letter 2021-9-30 · The Fair Debt Collections Practices Act gives you the right to send a letter to a collection agency telling them to stop contacting you.

The information that may be disclosed to a collection agency includes the debtor's name, address, Social Security number, date of birth, account number, payment history and the name and address of the health-care facility or provider.

Keep a copy for your records.

The letter can also point out billing mistakes and request verification of the debt (such as a copy of the contract that you signed). If the collection agency does not honor this request, you can sue them.
