If after you have sent the letter requesting they stop they still contact you and persist with harassment, you can sue the debt collection agency.

This law, effective as of J, prohibits debt collectors and creditors from engaging in certain unfair or deceptive acts or practices while attempting to collect debts.

You still might be sued or have debt reported to a credit bureau.

The Fair Debt Collection Practices Act applies only to debt collection agencies, collection attorneys and to the IRS.
