Before we begin, here are some important tips: In the upper part of the communication on the right, we list the fiscal year we are looking at. When we use the fiscal year, we mean that year. Any document you send must cover the year we are checking. Do not send original documents. Send us copies. Income credit (EIC) The first item listed is earned income credit (EIC). Your package includes a 886-H-EIC PDF form that lists a l l the different documents you can send to prove you can claim the EIC with one or more qualified children. You can send any combination of these documents to provide the information we need. Look at the EIC program that you presented with your tax return and complete the following steps for each qualifying child listed: First, you have to prove that you have lived with your child in the United States to half of the fiscal year: If your child has lived with you at the address indicated on your notice, you must send a document showing your child lived at the same address for more than half of the fiscal year. For example: you can send copies of the school records for the child who have your name and show the address of the child. The dates of the document must be more than half of the fiscal year (forecords that might need more than a semester to show more than the middle of the year). If you have moved and you and your child have lived at a different address, you must send documents showing the same address for both for more than half of the tax year. If your child has not gone to school, you can send copies of medical documents or a statement from a kindergarten provider. If you need to get an affirmation from your child's school, kindergarten or health care provider, you can find the patterns here. Your school or provider can copy and paste the template on their card to make sure all the required information is provided. Don't forget to check the 886-H-EIC PDF form for more examples of documents you can send. If you can't prove that your child has lived with you for more than half of the tax year, you can't get an EIC. Secondly, you need to check how attached you are to the child. The child must be related to you in one of the following ways: Your son, daughter, adopted son, underage son, adopted son or a descendant of one of them, such as your grandson Brother, sister, middle brother, middle sister, step brother, step sister or a descendant of one of them, such as a granddaughter or nephew 886-H-EIC PDF module provides examples of what to send to demonstrate how you are related. Thirdly, if the child is 19 years of age or older, you must verify that: The child was under 24 years of age and a full-time student for at least five months of the fiscal year (you can do so by sending copies of official school documents), or Your child is permanently and totally disabled (you can do so by sending a copy of one of the official documents listed on the 886-H-EIC PDF). Fourth, you need to verify the user, spouse (if filing a joint return) and child have a valid SSN: To claim the EIC, the user (and spouse, if filing a joint return) must have a valid SSN issued by the Social Security Administration (SSA) by the 2020 return date (including extensions). Any qualifying child listed in the EIC program must also have a valid SSN by the 2020 return date (including extensions). You can only claim the EIC if your child has lived with you for more than half of the tax year in the United States. Your child must also be tied to you in one of the ways listed in the 886-H-EIC PDF form, and be an eligible age. Your child must meet all three of these requirements to qualify for the EIC. If you can't prove that your child meets all the requirements, you may still be eligible for the EIC without a qualifying child. Employees The next item is the employees you claimed. Your employees are listed in the middle of the first page of the tax return. Form 886-H-DEP PDF lists all documents or the combination of documents that you can use to prove that you can claim any child named as your employee. To claim a child as an dependent child, the child must have lived with you for more than half of the fiscal year (the residency test), be linked to you (the relationship test), be a certain age (the age test), et cetera), have not provided more than half of their support (support test). If every child listed in your EIC program is the same child that you have declared dependent, you can use the same documents that you have used to prove that you can ask the EIC to prove that the child has fulfilled the tests for a qualified child in charge. You do not need to send copies of the same documents or look for different documents. However, it is necessary to use module 886-H-DEQUI19: 160? PDF to see what information needs to be provided to verify that the child complies with the support test. Support test To meet the support test, the child cannot pay more than half of its support. You don't have to send evidence of support right now. If you have received this CP75 notification, you have applied 160: a child as an dependent child. If you find that the child does not comply with the rules to be your qualified child, you may be able to claim the child as a qualified dependent relative. See the rules relating to Module 886-H-DEFLA19: 160? PDF for a relative qualification. If the child complies with the rules, it is necessary to send the documents listed in form 886-H-DEPB194: 160PDF for a relative qualification. File Status The next item listed was storage status. Look at the first page of your tax return, the first line shows your storage status. If you have submitted as head of family, you must look at form 886-H-HOH 160; PDF listing all the different documents or combinations of documents you can send to show that you can request this deposit status. To be head of the family, you need to pass three tests: the marriage test, the test of the qualified person, and the cost of maintaining a home test. First of all, you must take the marriage test: If you have never been married or widowed or widowed, do not present anything for the marriage test. Provide documents only for the qualified person and the costs of maintaining a home test. If you're still married and living with your spouse at any time during the last six months of the year, you can't apply as a first-name, unless your spouse was a non-resident alien at any time during the fiscal year. Instead, if you have to present itself as filing marriage together or marriage separately. If you are divorced or legally separated from December 31 of the tax year indicated on your notification, you must send a copy of your divorce decree or divorce papers. If you are still married but lived separately for the last six months of the fiscal year indicated in your notice, you must send us documents, such as a copy of a lease, showing you and your spouse lived in different addresses. The next is the qualification test: the documents sent to the EIC and to have an employee qualification will show you to have passed this test. So there's no need to send us any more documents for this test. The third is the cost of maintaining a home test: If you have not satisfied both the marriage and the person qualification test, you cannot register as a family leader. If you have met both the marriage and the test of the qualified person, you must send the documents indicating that you have paid more than half the maintenance costhouse where the qualified person and you have lived for more than half of the tax year. You must send us documents proving that you have paid more than half of the household expenses, such as rent, utilities, groceries, repairs and maintenance. If the qualified person was your parent, you did not have to live with your parent, but you have to prove that you paid more than half the cost of maintaining a home for your parent for the entire fiscal year. If another archive status other than the main family name is used, no documentation is required at this time. American Opportunity Credit The next section is American Opportunity Credit (AOTC). If you have supported AOTC, you need to fill out form 8863, Educational Credits (American Opportunities and Lifetime Learning Credits) is PDF and send it with the income statement. Also, look for one or two entries on your income statement for the lines listing "educational credits" or "American opportunity credits." If the income statement shows that you did not claim the credit, you do not need to send documents to prove the credit. If you have requested the AOTC, we need proof that every student listed in Form 8863 is suitable. Module 1098-T shows the amount of eligible education expenditure paid in box 1. We need a copy of that form. If you have had more than the amount indicated in box 1 of Form 1098-T, we need canceled cheques or receipts for taxes, books and supplies necessary for the course or courses. If you have additional items listed Your notice may have more items listed, such as Premium Tax Credit or Schedule C income. First, we will examine other important information that you need to know. Business costs are the costs you paid to carry on your business and proof of your expenses includes cancelled checks or accounting statements that clearly show the expenses you paid, cash tapes, bank statements, credit card sales cards, and invoices. If you need more information about recording, see Publication 583, start a Business and keeping Records. Premium Tax Credit If your notice lists Premium Tax Credit (PTC), see Form 14 950, Premium Tax Credit Verification is 160PDF. This form lists the document (s) you must submit to verify that you are eligible for this credit. To get this credit, you need to have health insurance through an exchange or a market. If you did not get health insurance through an exchange or market, you are not eligible for the PTC and do not need to submit any information to prove this credit. If you purchased your insurance through an exchange or market, you must submit copies of the documents used to support the entries you have on Part 4, Allocation of Policy Amounts or Part 5, Alternative Calculation for Marriage Year, on Form 8962, Premium Tax Credit (PTC).
